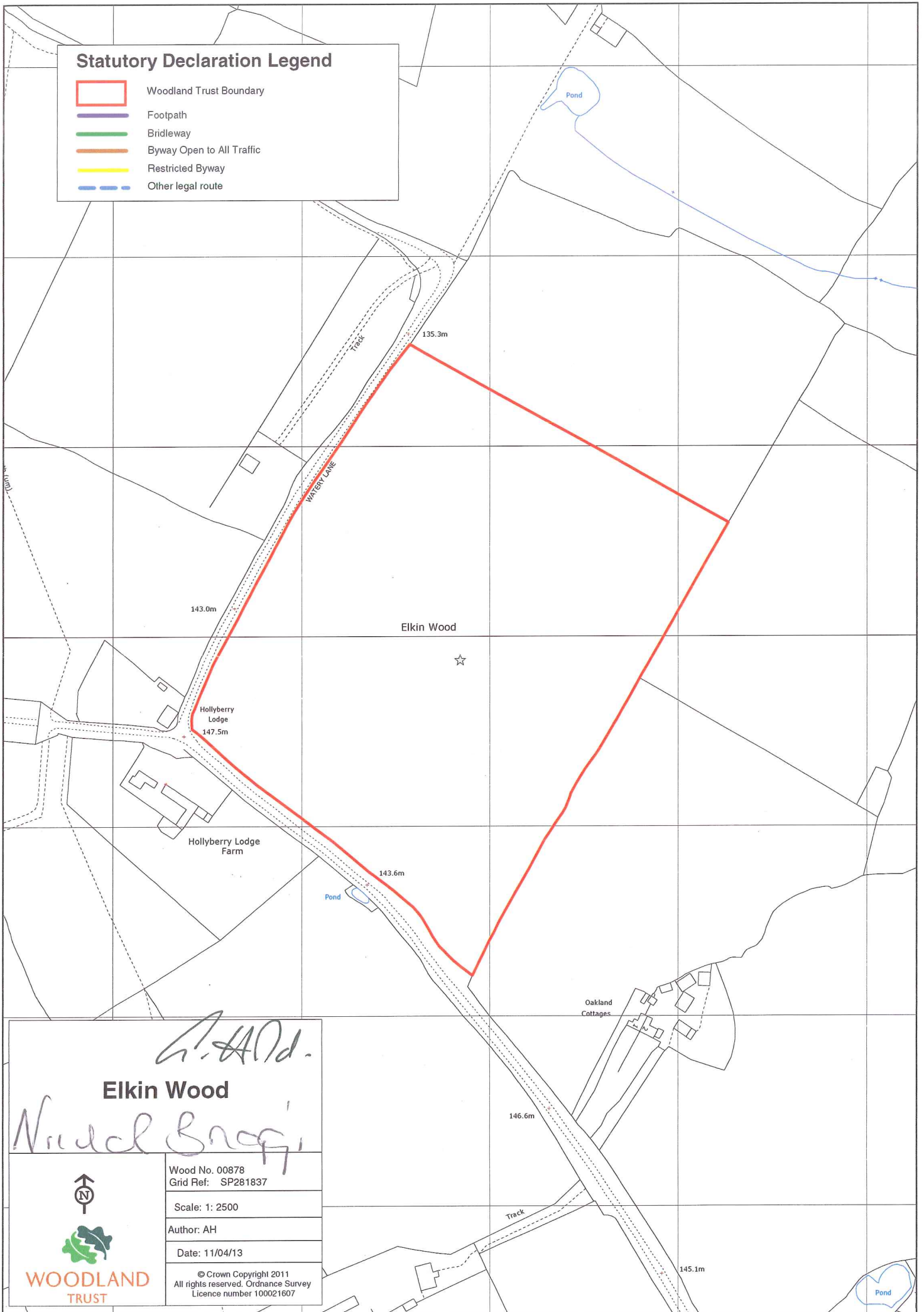

STATUTORY DECLARATION

HIGHWAYS ACT 1980 SECTION 31 (6)

I AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 12 September 1997 the owner of the land known as Elkin Wood, nr Corley Moor more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 21 November 2003 the Woodland Trust deposited with Coventry District Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that:
 - no ways had been dedicated as highways over our property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 21 November 2003 referred to in 2 above and at the present time the Woodland Trust has no intention of dedicating any more public rights of way over its property.
