Thank you for your FOI request, received on the 18 March 2015. Your request has been considered under the above legislation.

You have requested the following information:

Details of any incidents since the start of 2014 where food on sale in your area was found not to contain the ingredients listed or to be contaminated by other ingredients.

Response:

Lamb Donner in Naan purchased contained significant amounts of chicken.
Formal follow-up Sample Lamb Donner in Naan contained in excess of 10% chicken.
Lamb Keema contained 50% beef
Lamb Keema follow up sample contained 54% beef
Beef Mince with trace of lamb.
Minced Beef with trace of pork.
Minced Lamb with 2.4% beef.
Balti Lamb Tikka Masalla - over 10% beef 5% chicken
Cottage Pie contained no beef just lamb and poultry.
Lamb Tikka Masalla ordered without nuts but trace of peanuts found.
Lamb Korai contained beef and poultry.
Grilled Lamb Donner contained 5% chicken and 5% beef.
Lamb Burger contained 10% poultry and 2% beef
Indian sweet sample contained non permitted food dye.
Indian sweets contained non permitted food dye.
1 kg Beef - contained small amount of lamb.

Chicken breast with 8% of added water not declared.

Lamb Burger contained 1% beef and 1% chicken

Lamb Joypur contained a significant amount of goat and trace of beef and poultry.

Lamb Tikka Rezzela contained trace of chicken.

Lamb Curry contained trace of chicken.

Lamb Donner Meat contained significant amounts of chicken.

Beef Mince.

Steak Mince Sample + APT.

Lamb Mince - formal + APT.

Spicy Beef Noodles found to be irradiated.
