#### Introduction

#### **When to use this form**

This regime is known as Local Authority Integrated Pollution Prevention and Control, LAPPC under the Environmental Permitting Regulations 2010 (The "EP Regulations"). Installations permitted under this regime are known as B installations. Use this form if you already have a permit and have ceased to operate, or intend to cease to operate your installation and wish to surrender the permit. You may apply to surrender the whole or part of your permit.

Operator has mothballed Curriers Close site due to reduced throughput and capacity since permit date of 31.07.12. Forecasts show this reduced throughput will continue and will not reach 5 tonne permit threshold. Operator would like to surrender rather than mothball permit again. Main emissions when in use are water-based materials: NP1304 primer (0.6T purchased in 2014) and ACMOSIL 34-5502 (0.2T purchased in 2014) - MSDS provided. The main solvent in use is methylene chloride for flushing (non-SED activity) and approximately 1T was used in 2014.
