#### What is PSW?

Care Act 2014 states a PSW should;

- be visible across the organization
- support and develop effective conditions for practice
- oversee quality and improvement of practice
- have direct contact with the Adults Director and front line

PSW for Adults is Andrew Errington commenced in post in July 2016

Andrew is the Head of Safeguarding and Practice Development and reports to Director of Adult Services Pete Fahy

#### Workforce Development

Produced a Workforce Development Strategy and Plan

Established a Learning and Development portfolio for Adults, ensuring access to a range of relevant and current training opportunities. "28 training events relevant to Social Work attended by 398 staff"

Hosted a 2nd annual practice week with the Children's PSW. "29 sessions over 5 days, with 1250 places. 66% of attendees rated the quality of learning as excellent"

# Strength Based Approaches

Supporting staff to take a strength based approach

"More than 80 staff attended five training sessions on strength based practice"

Commenced a new Risk Enablement Panel, having 7 in depth discussion panels

Exploring opportunities for Family Group Conferencing (FGC) or family led meetings

New roles are supporting our newly qualified Social Workers, promoting Practice Education, providing practice support to staff and supporting 'Making Every Contact Count'

"Offered 14 placements for Social Workers"

"3 new SW Practice Educators trained"

# Practice Quality

Implemented a new Practice Quality Assurance Framework for adult social care. "145 audits undertaken"

New guidance produced to enable workers to close their own assessments.
