Thank you for your request for information relating to the Coventry Railway Station and Railway Multi Storey Car Park for which we apologise for the delay in responding to you.

You have requested the following information:

Please may I request an up to date list of contractors, subcontractors and suppliers that have or will be involved with the redevelopment scheme around the railway station involving demolition of buildings (except Coventry Railway Station and Railway Multi Storey Car Park) and construction of buildings in a mixed-use scheme. The scheme will be predominantly office-led (use class B1) and include shops (use class A1), financial and professional services (use class A2), restaurants and cafes (use class A3), drinking establishments (use class A4), hot food takeaways (use class A5), hotels (use class C1), residential institutions (use class C2), residential (use class C3), non-residential institutions (use class D1), assembly and leisure (use class D2), student housing and vehicular showrooms. There will also be new transport interchange facilities and car parking and increased open space provision. This will include associated infrastructure, access road, sewer system, enabling works and landscaping. (1&2 Friargate)
