## Freedom of Information Act 2000 (FOIA) Request ID: REQ06051

Thank you for your request for information relating to Diesel cars bought for staff.

Your request and our response are outlined below:

Please tell me how many diesel cars were bought for staff in the last three financial years (2016-17, 2017-18 and 2018-19). I am interested only in those diesel cars which were given to staff under the agreement that they would be used for both work and non-work purposes.

We can confirm that we have not purchased any cars in the above years to give to staff in the above circumstances.

For each of the cars bought, please state the model of the car, the amount it cost and its CO2 emission tax excise band (explained: <u>https://www.gov.uk/vehicle-taxrate-tables</u> - answer could be 0, 1-50, 51-75, 76-90, etc.).

This is not applicable, please refer to question 1.

Please tell me if a diesel car was provided over the same period to the Chief Executive. If yes, please tell me the model, its cost and the CO2 emission tax excise band for this vehicle(s).

We can confirm that no Diesel car was provided over the same period to the Chief Executive.

Finally, for the same time period, please tell me how many non-diesel cars were bought and given to staff for use at work and outside of work. We can confirm that no non-diesel cars were bought and given to staff for use at work and outside of work.
