Thank you for your request for information relating to agency staff for schools.

You have requested the following information:

I would like to know how much each Primary, Secondary and Special Needs school spent on temporary supply staff from 1st September 2019 - 9th December 2019. I would like to know the total spend for each school and which third party private supply teaching agency/s were used.

We advise that the Council can only provide this information for maintained schools. The latest information that we currently hold is for the financial year ended 31st March 2019.

The information for the year ended 31st March 2019 is publicly available as a response to an earlier FOI request. A link to this FOI response is included below;

Please note that we do not hold this data for academic years, it is held on a financial year basis only. If you require an analysis of part year information you would need to contact each school for this information.
