Thank you for your request for information relating to Electric charging points 2016 to 2019.

Your request and our responses are outlined below:

1. The number of electric charging points for electric vehicles installed by the council in 2016?

There were 5x fast electric charge points and one rapid charge point in the City for all to use from 2016b till September 2016 as follows.

- Croft Road (1 chargepoint)
- War Memorial Park (3 chargepoints)
- Little Park Street (1 chargepoint)

2. The number of electric charging points for electric vehicles installed by the council in 2017?

There were 5x fast electric charge points and one rapid charge point in the City for all to use from 2016 till September 2017 as follows.

- Croft Road (1 chargepoint)
- War Memorial Park (3 chargepoints)
- Little Park Street (1 chargepoint)

3. The number of electric charging points for electric vehicles installed by the council in 2018?

There were 5x fast electric charge points and one rapid charge point in the City for all to use from 2016 till September 2018 as follows.

- Croft Road (1 chargepoint)
- War Memorial Park (3 chargepoints)
- Little Park Street (1 chargepoint)

There were additional 6 rapid chargers installed and made available in September 2018.

4. The number of electric charging points for electric vehicles installed by the council in 2019?

Slow – 80 [3.5kW] installed by end of 2019

Fast – 28 [7kW and 11kW] installed by end of 2019 and

Rapid – 33 [50kW] installed by end of 2019
