- How much money has been spent on road maintenance over the last three years in your area?
- What is your local 2020 budget for road maintenance?

The figures below are the total budget and spend for the following Highway assets only: Roads and footways. Further budget and spending is available for other Highway assets including; bridges/ structures, one off specific projects and highway drainage. Funds are made up of monies received via Dft maintenance grants and pothole funding streams and local corporate capital resource.
