Thank you for your request for information relating to the Council's energy and printing bills and new street trees planted.

You have requested the following information:

- 1. The Council's total energy bill, including the cost of street lighting, for each of the financial years:
- **a. 2016/17?** £3,764,904.67
- **b. 2017/18?** £4,247,756.29
- **c. 2018/19?** £4,288,258.75
- 2. The Council's total printing bill, for each of the financial years:

# a. 2016/17?

The system used to track mono and colour corporate printing costs during 2016/17 were not implemented at this time.

£301,502.01 was paid to our supplier in relation to print costs during 2016/17 financial year.

### b. 2017/18?

£484,270 mono and colour corporate printing costs.

### c. 2018/19?

£338,260 mono and colour corporate printing costs.

- 3. The number of new street trees that the Council has planted for each of the financial years:
- a. 2016/17?
- b. 2017/18?
- c. 2018/19?

For Questions 3a to 3c, we do not have specific information on street tree planting as the Council's tree planting programme covers all tree types and across all sites. This information is held by calendar year. Please see the table below:
