6. How many individual coronavirus cash grants ( $£ 25,000$ grants) have been sent out to fashion retail businesses between 17 March and 27 April?
7. What is the total sum of coronavirus cash grants ( $£ 10,000$ grants) that have been sent out to fashion retail businesses as of 27 April?

We can confirm that we do not hold this information and are advising you as per Section 1(1) of the Act.

Coventry City does not hold records which would allow us to confirm numbers of grant recipients that would be considered as fashion retailers based on the description provided. These grants are awarded using our business rates records which use Valuation Office Agency property descriptions, and these do not distinguish between different types of retailers. The Department for Business, Energy \& Industrial Strategy regularly publishes data on the number and value of all grants awarded through these schemes for all local authorities.

Should you wish to make any further requests for information, you may find what you are looking for is already published on the Council's web site and in particular its FOI/EIR Disclosure log, Council's Publication Scheme, Open Data and Facts about Coventry.
