Your request and our responses are outlined below:

Please could you provide details of how much money the Council spent on the Black Lives Matter protests in Coventry on Saturday, June 27 and Saturday, June 20.

This should include traffic management and any other costs of the events.

Please also detail when notification was received from the organisers.

We can advise that the only costs incurred by the Council were in relation to Traffic Management and as follows:

Sat 20th June - £5213.35

Sat 27th June - £ 6344.48

- 20:04 on Friday 26th June Council received event plans from the organiser with written details of the event
