Thank you for your request for information relating to Next Steps Accommodation Programme.

You have requested the following information:

1.Has your Council applied for money from the Next Steps Accommodation Programme (NSAP) since it was announced on 18th July?@

Yes.

2.If so, how much money has been bid for?

The Governments NASP funding stream required Local Authorities to submit bids by the 20th August 2020. We can confirm that CCC submitted a proposal to secure both revenue and capital funding and we await the outcome of this bid. It therefore wouldn't be appropriate to disclose the amount at this point.

3. How many homeless people were housed by your Council, by month, since February 2020?

The number of homeless people housed under the 'Everyone In' scheme (emergency Covid-19 measures), by month, were:

02/03/2020 - 31/03/2020 - 88.

01/04/2020 - 30/04/2020 - 75.

01/05/2020 - 29/05/2020 - 32.

01/06/2020 - 30/06/2020 - 51.

01/07/2020 - 31/07/2020 - 44.

01/08/2010 - 25/08/2020 - 43.

Please note: These numbers include duplicates, for example where an individual may have been moved from one establishment to another, or left the accommodation then returned at a later date (and placed elsewhere). In total, 221 individuals have been accommodated during this period under the 'Everyone In' scheme.
