

City of Coventry (Off-Street Parking Places) Order 2005
(Charterhouse Drive Car Park)
(Variation) Order 2020

The Council of the City of Coventry ("the Council") in exercise of its powers under Sections 32 to 35 and Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act HEREBY MAKES the following Order:-

1. Citation and Interpretation

1.1 This Order is supplemental to the City of Coventry (Off-Street Parking Places) Order 2005 (as amended) ("the Original Order") which subject as hereinafter mentioned remains in full force and effect.

1.2 This Order shall come into operation on the [] 2020 and may be cited as City of Coventry (Off-Street Parking Places) Order 2005 (Charterhouse Drive Car Park) (Variation) Order 2020.

1.3 The definitions are as set out in the Original Order.

1.4 The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an act of parliament.

1.5 The restrictions imposed by this Order shall be supplemental to and not in derogation of any restriction or requirement imposed by the Original Order and any regulations made under the Act by any other enactment.

2. Variations Made

From and including the date of this Order the Original Order shall be read and construed as varied by the provisions set out in the Schedule

3. Original Order Remains in Force

The Original Order shall remain fully effective as varied by this Order.

THE SCHEDULE

Variations to the Original Order

1. Schedule 3

1.1 At the end of Schedule 3 the following shall be added:-

Column 1 – “Charterhouse Drive Car Park”

Column 2 – “Pay and Display”

Column 3 - "All vehicles not exceeding 1525kg unladen weight"

Column 4 – "All Hours, All Days"

Column 5 – “All Hours, All Days”

2. Schedule 7.

2.1 At the end of Schedule 7 the following shall be added:-
