Thank you for your request for information on Pay and Display Transactions and Income.

Your request and our responses are outlined below:

For the period 01/04/2019 to 31/03/2020:

1. The total number of Off Street pay and display parking transactions/tickets sold (all payment methods).

646,467.

2. The total number of On Street pay and display parking transactions/tickets sold (all payment methods).

We can confirm that we do not hold the information in the format you have requested above and therefore we are advising you as per Section 1(1) of the Act. The Council does not record the number of on-street cash transactions.

- 3. Total Off Street pay and display income (cash, credit/debit card, pay by phone). £4,045,055.67.
- 4. Total On Street pay and display income (cash, credit/debit card, pay by phone). £734,570.29.

5. Total number of Off Street pay and display parking transactions/tickets sold via a pay by phone provider.

105,140.

6. Total number of On Street pay and display parking transactions/tickers sold via a pay by phone provider.

98,940.

7. Total Off Street pay and display income processed via a pay by phone provider.

- 9. In relation to the Council's current pay by phone parking provider, can you tell me:
- a. What is the contract expiry date for your pay by phone parking provider, including any extension periods?

It is a rolling 12-month contract.

b. What is the current notice period required in order for the Council to exit this contract?

3 months.

c. What is the current contract value, annualised over the period 01/04/2020 – 31/03/2020?

£22,000 per year based on the period 1/4/2019 - 31/3/2020.
