

City of Coventry (Princethorpe Way, Quorn Way & Bredon Avenue Area)
(20mph Zone & Consolidation) Order 2021

Coventry City Council, in exercise of their powers under Sections 1(1), 2(1) (2) (3), 4 (2) and 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order shall come into operation on the day of 2021 , and may be cited as the "**City of Coventry (Princethorpe Way, Quorn Way & Bredon Avenue Area) (20mph Zone & Consolidation) Order 2021**"
2. In this order:
 - (a) A reference to an article followed by a number is a reference to the Article of this order so numbered
 - (b) "vehicle" means:-
 - (i) a mechanically propelled vehicle intended or adapted for use on the road
 - (ii) a pedal cycle in actual use for the purposes of cycling
 - (c) "pedal cycle" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016
 - (d) The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Save as provided in Article 4 of this Order, no person shall cause or permit any vehicle to be ridden or driven at a speed exceeding twenty (20) miles per hour on the length of roads specified in the First Schedule to this Order.
4. Nothing in Article 3 of this Order shall apply to any vehicle being used for Police, Fire or Ambulance purposes in circumstances of emergency.
5. The orders referred to in the Second Schedule to this Order are hereby revoked to the extent specified therein.
6. The restrictions, prohibitions and requirements imposed by this Order shall be read and construed as not being in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.
