Please Note:

- The City Total in this case refers only to primary, secondary and special schools.
 Data is collected from other small units, but not reported here as the low numbers of pupils could lead to pupil identification. There should be little effect on summary data.
- 2) The Number of Pupils on Roll includes only pupils on roll at schools returning information. The source is the January School Census

From Spring 2016 the City Council stopped compiling this information from schools. This was in part due to changes with the Data Protection Act 2018, GDPR and the requirements around sharing with a third party, but also because since the Equalities Act 2010, schools have not been legally obliged to share the incidents and the data we were receiving was therefore not representative of the complete picture of what might be happening in Coventry Schools.

Schools are however, required to keep a record and report to their own governing bodies.
