## STATEMENT OF REASONS

The City of Coventry (Citywide) (Permitted Parking Area and Special Parking Area) (Designation, Waiting Restrictions, Loading Restrictions, Loading Areas and Street Parking Places) Consolidation Order 2016 – Variation 10

A number of road safety concerns have been raised by local residents in regard to problems caused by drivers parking at junctions, reducing visibility of and for exiting vehicles and in other locations, such as on bends. Concerns have also been raised in some areas about overnight lorry parking. It is proposed to install waiting restrictions at these locations to prevent parking and improve road safety. In addition, in other areas issues have been raised regarding all day commuter parking; residents' parking schemes or controlled parking zones are proposed in these areas.

Changes to restrictions are also proposed as part of highway works relating to safety schemes.

Some changes are proposed to reduce double yellow lines, where possible, to create additional on street parking.

Reviews of existing restrictions have shown that there are some inconsistencies between Orders and restrictions indicated on the ground and these anomalies are being resolved by remaking the Orders.

The locations referred to above where changes are proposed are detailed in Appendix A

In addition, some changes are proposed due to new developments; these are detailed in Appendix B.

It is also proposed to amend Schedule 4 to detail properties on:

Brays Lane, Nos 2-66a (evens), Nos.74-84 (evens), Nos 13-73 (odds), Nos 89-115 (odds) and 2 Ethelfield Road as eligible to apply for Zone BH Parking Permits (for permit zone Ball Hill Area)

## **REASONS**

When considering whether to make a traffic order the Council is under a duty pursuant to S.122 Road Traffic Regulation Act 1984 (as amended), to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway having regard to the matters specified in S.122 (2). It is considered that the proposals will generally assist to secure the safer movement of vehicular and pedestrian traffic. Furthermore, it is considered that the proposals will affect the matters specified in S.122 (2) as follows:

(a) the desirability of securing and maintaining reasonable access to premises;

The proposals will assist with the movement of traffic

(c) the importance of facilitating the passage of public service vehicles and of securing the safety and convenience of persons using or desiring to use such vehicles: and

The proposals will assist with the movement of traffic

The restrictions are to be installed in accordance with Section 1, Road Traffic Regulation Act 1984 as it provides that the Traffic Authority may make a Traffic Regulation Order, where it appears to the Authority making the order, that it is expedient to make it -

for avoiding danger to persons or other traffic using the road or any other road or preventing the likelihood of any such danger arising

for facilitating the passage on the road or any other road of any class of traffic (including pedestrians)

The Director, Transportation and Highways has delegated powers to request the advertisement of Traffic Regulation Orders.
