## **PROPOSED TRAFFIC ORDER**

Coventry City Council ("the Council"), under the Road Traffic Regulation Act 1984 (as amended), propose to make the following Order:-

City of Coventry (Citywide) (Permitted Parking Area and Special Parking Area) (Designation, Waiting Restrictions, Loading Restrictions, Loading Areas and Street Parking Places) Consolidation Order 2016 – (Variation 10) Order 2021

The Order proposes to implement the following:-

A number of road safety concerns have been raised by local residents with regard to problems caused by parking. The problem parking causing obstruction or at junctions reducing visibility of and for exiting vehicles or relating to overnight lorry parking. It is proposed to install waiting restrictions at these locations to prevent parking and improve road safety. In addition, following reviews it has been shown that there are some inconsistencies between Orders and restrictions indicated on the ground and these anomalies are being resolved by remaking the Orders

It is proposed to install 1 new residents' parking scheme:

Zone BH - Brays Lane

The effect of the proposed Order is to add to, vary or amend the waiting restrictions on certain lengths of the following roads:
