- The details of each individual complaint including the date it was raised, what the complaint was regarding,
- The details of any investigations that have been undertaken to investigate the alleged nuisance.
- Details of any visits or monitoring undertaken including, dates, times, duration on site, copies of any data collected

- · Copies of any correspondence regarding the complaints and the investigation; and
- A copy of the Councils Enforcement Policy and any internal procedure or guidance regarding nuisance complaints and investigation.

Coventry City Council has not received any odour nuisance complaints from local residents due to the operation of the City Arms Wetherspoon Free House at 1 Earlsdon St, Earlsdon, Coventry CV5 6EP
