Freedom of Information Act 2000 (FOIA) Request ID: FOI364196060

Thank you for your request for information relating to 5G mast erection across the city.

You have requested the following information:

- 1. I would like to know the name of the businesses in which the 5g masts belong to? Such as Hutchison 3G, Vodafone, EE (etc)
- 2. The locations (by road name) in which the 5G masts are and the date in which they were erected?

For Questions 1 and 2, the data relating to 5G planning masts can be found on the following link:

https://planningsearch.coventry.gov.uk/Planning

We therefore do not need to disclose the information as per Section 21 of the Act.

To assist, type "TEL" into the search function to identify all details relating to telecom mast applications including who they are being installed by/for.

3. What monies, donations or contributory funds were received by any Coventry City Council departments to erect these 5G masts?

The Council receives a standard planning fee for the application, also viewable as part of the application documents. As the applicant is considered a 'statutory undertaker' no additional charge

can be made for masts erected on the highway (including footpaths).

4. What department of Coventry City Council deals with the erection of these 5G masts?

The applications come through to the Planning department, which consults with relevant departments such as Highways as well as notifying immediate neighbours and displaying a notice on site as part of the public consultation.

5. How many 5G masts have been erected in Coventry and any future plans to obtain more?

Please refer to Question 1.

To further advise, 5G mast rollouts are organised and co-ordinated by infrastructure companies and not by the Council.

The supply of information in response to a FOI/EIR request does not confer an automatic right to re-use the information. You can use any information supplied for the purposes of private study and non-commercial research without requiring further permission. Similarly, information supplied can also be re-used for the purposes of news reporting. An exception to this is photographs. Please contact us if you wish to use the information for any other purpose.
