Road	Change to original proposal
Barkers Butts Lane & Tomson Avenue	Removing the double yellow lines on Barkers Butts Lane (each side of the road outside No.s 14-24) and Tomson Avenue from the order.
Berkett Road /Romford Road	Reduced extent of double yellow lines to be installed.
Beresford Ave/Durbar Ave/ Churchill Ave	Removed from order
Biggin Hall Crescent/Grant Road	Reduced extent of double yellow lines to be installed.
Bracadale Close/ Coombe Park Rd	Removed from order
Branksome Road	Revocation removed from order (double yellow lines to remain)
Church Park Close, High St & Tamworth Rd	Install proposed double yellow lines, remove proposed school time waiting restriction from order and consult residents of Church Park Close about alternative restrictions.
Clayton Road/Donnington Avenue	Reduced extent of double yellow lines to be installed on Donnington Avenue
Dartmouth Road	Reduced extent of double yellow lines to be removed, removing 13m, not 18m as originally proposed.
Dronfield Road Area (Holmfield Rd/Enfield Rd, Dronfield Rd/Enfield Rd, Holmfield Rd/Druid Rd, Holmfield Rd/Harefield Rd, Beaconsfield Rd/Copperfield Rd)	Removed from order
Ivy Farm Lane, Cannocks Lane	Removed from order (to consult again with residents)
Keppel St/Cambridge St & Keppel St/Wright St	Removed from order
King Edward St/Leopold St, King Edward St/ Alfred St, King Edward St/Alexandra St	Removed from order
Lilacvale Way	Removed from order
Ralph Road	Reduced extent of double yellow lines to be installed.
Sandhurst Grove	Reduced extent of double yellow lines to be installed.
Silverdale Close/Wildmoor Close	Removed from order
Standard Avenue	Removed from order, monitor and if future road safety or obstruction issues, new proposals to be advertised as part of a future review.
Unicorn Lane	Reduced extent of double yellow lines to be installed.

When originally advertised the title of the Order (as proposed) was City of Coventry (Citywide) (Permitted Parking Area and Special Parking Area) (Designation, Waiting Restrictions, Loading Restrictions, Loading Areas and Street Parking Places) Consolidation Order 2016 - (Variation 10) Order 2021. The title has since been changed to that set out above.
