Thank you for your request for information relating to Warwick Road Bus Lane CCTV Camera - Penalty Notices.

You have requested the following information:

I would like to know how many penalty notices have been issued for vehicles driving through the outbound bus lane on Warwick Road since the routing on that road was changed - and how this compares to any other individual CCTV bus lane camera sites within the City for the same period.

Clarification Received:

To answer your request, please can you clarify the information you require is:

1. How many PCNs have been issued at the Warwick Rd bus gate since the bus lane enforcement camera was first implemented?

Yes – since the Warwick Road bus lane one way system was first implemented

125,127 PCNs have been issued at Warwick Rd bus gate since it was implemented in 2015/16.

2. In terms of the second part of the question, we can provide the number of PCNs issued at all bus gate/ lanes during the period since the implementation of the Warwick Rd bus gate camera to enable comparisons. Please confirm if we consider your request on this basis.

I would ideally like to see how the PCN's generated at Warwick Road compare to all other individual PCN bus lane areas in the city for a comparable period. If that information is not available – which would be disappointing – then the combined total of all PCN's together with total of bus lanes would give an average for comparison which is the next best comparison.

The following table shows the number of PCNs issued at all bus lanes and bus gates since the Warwick Rd bus gate was implemented.
