## Freedom of Information Act 2000 (FOIA) Request ID: FOI412262315

Thank you for your request for information relating to Fixed Penalty Notices for dog fouling and littering at Coundon Hall Park.

You have requested the following information:

## 1. Please provide the number of Fixed Penalty Notices issued for littering offences committed at Coundon Hall Park (AKA Coundon Hall Sports Ground), Waste Lane, Coventry from 23 March 2019 to 23 March 2020.

We hold the information which you have asked for, but we have estimated that the cost of meeting your request would exceed the cost limit of £450 specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees Regulations 2004). This represents the estimated cost of one person spending 18 hours or more, in determining whether the information is held, locating, retrieving and extracting it.

We estimate that because the information regarding the location of the offense is recorded specifically on the file and this is a nonreportable format. It would require an officer to manually review 1,388 records to identify the requested information and this has been estimated to exceed the 18-hour limit under the Act. Your request has been refused under section 12(2) of the Act.

However, in order to fulfil our obligations under Section 16 of the FOI Act to advise and assist you, we advise that information regarding fixed penalty notices are published on the Council's website and can be found on the following link:

## 2. Please provide the number of Fixed Penalty Notices issued for dog fouling offences committed at Coundon Hall Park (AKA Coundon Hall Sports Ground), Waste Lane, Coventry from 23 March 2019 to 23 March 2020.
