Thank you for your request for information relating to the Climate Change Board and progress of its Climate Change Strategy.

You have requested the following information:

At a recent public meeting, CCC's Head of Sustainability & Climate Change, claimed in response to a verbal request for more information about the Climate Change Board that all the documents relating to its terms of reference, responsibilities, and scrutiny arrangements were publicly available.

However, I have not been able to find these documents online.

I have now repeatedly requested this information via my local Councillor Bally Singh, and have had no response.

I am now, therefore, writing to you under the Environmental Information Regulations and Freedom of Information Act 2000 to request the following information from you.

- (d) reports on the implementation of environmental legislation;
- (e) cost-benefit and other economic analyses and assumptions used within the framework of the measures and activities referred to in (c)]

I would like to see any information relating to the following:

1. The purpose of the Climate Change Board, and how it relates to the formulation of CCC's new Climate Change Strategy

Coventry's Independent Climate Change board has been set up to help shape and move forward actions to reduce the impact of climate change. The aim is to share policies, plans, good practice and work together collaboratively in an effort to keep the city on track for a zero-carbon future.

Coventry City Council's One Coventry approach includes collaboration with stakeholders across the city. Coventry's independent Climate Change Board is an example of how we work with partners to tackle the effects of climate change and is highlighted as part of the strategy and will go out for consultation later this year.

2. Terms of reference or equivalent for CCC's Climate Change Board

Please see the attached document.

3. Details as to how the work of this board will be held accountable and/or scrutinised by elected representatives

The Climate Change Board is a city-wide independent board of which the Council are a member. The Climate Change Board is not directly accountable to the Council however it works closely and collaboratively together for the benefit of the city.

4. Any financial arrangements this Board has entered into with its members or with outside organisations

The Climate Change Board has not entered into any financial arrangements with its members.

5. Any existing minutes of meetings and meeting papers presented to this Board so far

The minutes are not currently publicly available however will be once the governance procedures are finalised, and the mechanism agreed to release this information into the public.

6. Details as to how such minutes/documents will be made publicly available before and after meetings

The Climate Change Board is not a public meeting however press releases are made regarding the progress of the board.

7. How the public can find out when this Board meet The Board will meet at least once a quarter. The dates are agreed by the Chair and Vice Chair.

This information is not published publicly as it is not a public meeting

8. How members of the public can feed into these meetings, given that only one Cllr is on the Board itself

The Board has set up a number of working groups, one of which has a specific remit for addressing inequities which includes public engagement.

9. Agreements or correspondence with Confirmation that CCC is working with Andy Gouldson, Professor of Environmental Policy at the University of Leeds and founder of the ESRC Place-based Climate Action Network (PCAN)

Coventry City Council are working with Professor Andy Gouldson and have commissioned a Net Zero route map for Coventry enabling us to benchmark against other cities such as Glasgow, Edinburgh, Belfast, Swansea and Leeds.

Please see attached an email sent from Head of service to confirm the success of the tender.

The Council is withholding some of the requested information in this case as it falls under; the exception(s) in Regulation 13 of the Regulations which relates to Personal Data. The Council has applied the provisions of Regulation 13 in respect of this information as it judges it to fall within the definition for personal data set out in Section 3(2) and 3(3) of the Data Protection Act 2018 (DPA) as:

- (2) personal data means any information relating to an identified or identifiable living individual (subject to subsection (14)(c))"
- (3) "Identifiable living individual" means a living individual who can be identified, directly or indirectly, in particular by reference to –
- (a) an identifier such as a name, an identification number, location data or an online identifier, or
- (b) one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of the individual."

The Council considers that this information is caught by the above exception to disclosure and to explain further, a disclosure made under the provisions of the Regulations is judged to be a disclosure to the wider world and here the Council must consider disclosure of personal information in line with the provisions of the DPA.

In this instance it is judged that the personal information relating to junior council officers involved is being processed by the Council for the purpose of maintenance inspections.

All personal identifiers and information relating to the officers have therefore been redacted (removed) from the supplied information. Individuals involved would also have no reasonable expectation that their details would be disclosed to the world-at-large.

Any disclosure of this information would be judged in this instance to breach DPA

principles, notably the first principle – that of fair and lawful processing and the second principle-that of processing for specified and not-incompatible purposes. Personal identifiers have thus been redacted in this instance.

10. Details as to in what way CCC is working with Prof Gouldson, and at what stage this work is currently at.

We have received the first draft of the Net Zero routemap and are working through the data before it is published and circulated wider.

We aim to publish the Net Zero routemap this Summer 2022.

11. Agreements or correspondence with the PCAN network Whether CCC has applied to be part of the PCAN network, and/or any other relevant climate-related networks or organisations.

Coventry City Council are part of PCAN and have attended various PCAN meetings with other member authorities.

There was no formal application process to be part of PCAN other than being a Local Authority. Meetings are held publicly and can be found here:

The Coventry Climate Change Board

The Climate Change Board is all about individuals and the organisations they represent making things happen, working collaboratively and utilising resources to lead on the climate change agenda. The Board will be resolute in facing the growing challenges of resource consumption, pollution, loss of biodiversity and greenhouse gas emissions and their impacts on the environment, society and the economy. The Board will analyse issues, be challenging and innovative in solving problems, be task focused identifying opportunities, the necessary resources and priorities for action.

Terms of Reference

1.0 Vision and purpose

- "Creating a globally competitive City which provides a good quality of life to all of its citizens that is home to the Green Industrial revolution with a vibrant circular economy that provides a zero carbon environmentally sustainable and healthy future."
- 1.2 To build an active partnership across the public, private, charitable and community sectors to set individual and collective goals, working in partnership with communities in an integrated way to transform Coventry into a sustainable zero carbon city.

2.0 Membership – the stakeholders

2.1 The Council, public agencies, local businesses, charitable and community organisations.

3.0 Objectives

- 3.1 The Board will work collaboratively towards a common goal in developing a zero-carbon sustainable city by:
 - a) Developing a multi-agency strategy which identifies the issues that need to be addressed by the collective and collaborative actions of the Partnership
 - b) Securing commitments and agreeing roles and responsibilities for delivering specific integrated initiatives and actions within a comprehensive Action Plan which

addresses sustainability through the following five International Council for local Environmental Initiatives development pathways:

- 1 Low Emission Development
- 2 Nature Based Development
- 3 Equitable and People Centred Development
- 4 Resilient Development
- 5 Circular Economy Development
- c) Monitoring and evaluating the effectiveness in delivering actions across the Partnership and agreeing remedial action where necessary.
- d) Monitoring the state of the city and the effectiveness of the Action Plan in delivering the intended outcomes and the production of an annual (or bi annual) 'State of the City Report' identifying progress and its impact upon the quality of life of local people.
- e) Reviewing progress and revising commitments and actions for change
- f) Providing advice and support and lobbying for changes in national and regional policy.

4.0 Roles and Responsibilities

- To raise awareness of Climate Change and Sustainability and to identify strategic priorities and a develop a Strategy and policy framework for the city in relation to other national and regional sustainability and climate change strategies
- To work collaboratively in changing the culture of the organisations across the Partnership to assist their respective workforces to work in a more environmentally conscious and sustainable way.
- To share information and commission research to better understand issues as they relate to the development of a zero carbon sustainable city.
- To provide advice and guidance to key decision makers on matters concerning sustainability and climate change. To combine expertise and collectively problem solve issues which impact upon sustainability and climate change.

- To play a key role in supporting the development of new innovative services, products and technologies which place Coventry as a centre for the development of environmental technologies in the global economy creating sustainable wealth and jobs for the citizens of Coventry
- To identify solutions and secure resources and commitments from across the Partnership towards individual and collective actions which address sustainable development issues
- To develop a city-wide Action Plan that everyone signs up to.
- To generate investment and secure resources for programmes and projects identified in the Action Plan.
- To monitor and evaluate progress and to share data and intelligence to develop training and resources to improve skills and knowledge.

5.0 Meetings

- 5.1 All meetings will be Chaired by the independent chair and in her or his absence by the Vice Chair and will be held at least on a quarterly basis.
- 5.2 A meeting with require at least a third of its membership to be present in order to be quorate.
- 5.3 Decisions will be made by consensus. If not possible the Chair will have the casting vote.
- 5.4 Meetings of the Main Board will be held quarterly where appropriate working group meetings will be held to progress matters set by the Board and individuals or organisations may be co-opted to assist where necessary.

6.0 Amendments, Modification or Variation

6.1 This Terms of Reference may be amended, varied or modified in writing after consultation and agreement of the Climate Change Board
