Thank you for your request for information relating to homeless children.

You have requested the following information:

1. The number of households assessed by your local authority as being owed a prevention or relief duty due to risk of homelessness in 2018/19, 2019/20, 2020/21 and 2021/22 (or as recent as figures are held)

Following careful consideration, the information you requested falls under the exemption(s) in Section 21 of the Freedom of Information Act 2000, which relates to 'information reasonably accessible to the applicant by other means.'

The annual tables have been published for 2018/19, 2019/20 and 2020/21. The annual table for 2021/22 has not yet been published but the information will be available soon. The annual table for 2021/22 is due to be released on 22 September 2022.

This exemption is not subject to the public interest test.
