Thank you for your request for information relating to number of households presenting as homeless that claim Universal Credit.

You have requested the following information:

I write to request information on the number of households claiming Universal Credit and/or housing benefit who have presented to you as homeless while between January 2019 and April 2022.

Clarification: The request relates to people living in a leasehold property: households living in privately rented properties, owner occupiers and properties leased to council.

As part of this request, I would like this information to be broken down into the following:

- 1. The total number of households claiming Universal Credit presenting as homeless since January 2019, broken down into households living in leasehold property and council-owned property (otherwise known as council tenants) and years;
- 2. The total number of households claiming housing benefit part of the legacy welfare system presenting as homeless since January 2019, broken down into households living in leasehold property and council-owned property (otherwise known as council tenants) and years.
