## City of Coventry (Butts) (Prohibition of U Turns) Order 2023

Coventry City Council, in exercise of their powers under Sections 1(1), 2(1) (2) (3), 4 (2) and 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. This Order shall come into operation on the day of 2023 , and may be cited as the " City of Coventry (Butts) (Prohibition of U Turns) Order 2023"
- 2. i) In this order:
  - (a) A reference to an article followed by a number is a reference to the Article of this order so numbered
  - (b) "cause" includes permit and causing shall be construed accordingly
  - (c) "enactment" means any enactment whether public, general or local and includes any order, bylaw, rule, regulation, scheme or instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of a subsequent enactment;
  - (d) "vehicle" means
    - (i) a mechanically and/or electrically propelled vehicle intended or adapted for use on the road,
    - (ii) a pedal cycle in actual use for the purposes of cycling

which for the avoidance of doubt shall include the whole or any part of a vehicle.

- (e) The following expressions shall have the meanings assigned to them:-
  - "the 2016 Regulations" means the Traffic Signs Regulations and General Directions 2016 and includes any enactment or re-enactment or amendment thereto;
  - "pedal cycle" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;
- ii) The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament
- 3. Save as provided in Article 4 of this Order, no person shall cause or permit any vehicle proceeding on Butts to make a "U" turn, so as to proceed in the opposite direction on Butts, between its junction with Sovereign Row and its junction with Albany Road/Butts Road.
- 4. Nothing in Article 3 of this Order shall apply to any vehicle being used for police, fire or ambulance service purposes in in circumstances of emergency.

- 5. The City of Coventry (Butts) (Prohibition of U Turns) Order 2008 is hereby revoked in its entirety.
- 6. The restrictions, prohibitions and requirements imposed by this Order shall be read and construed as not being in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.
