Thank you for your request for information relating to Dangerous Dogs.

You have requested the following information:

Are you able to provide the exact numbers for the postcodes with the most reports of dangerous dogs in Coventry? I want the number of reports for each postcode and the list of areas for the postcodes in Coventry. I would also like to know the number of welfare reports for dogs and the number of stray dogs in Coventry. I would like data for the last three years up until the present day.

In response to your request, please see below. Please note that the data provided for each postcode below is the total number of all reports of dangerous dogs, combined with the total number of dog-on-dog attacks within Coventry. We do not record this data separately on our system.
