CITY OF COVENTRY (UPPER SPON STREET) (PROHIBITION OF DRIVING and REVOCATION) ORDER 2023

Coventry City Council, in exercise of their powers under Sections 1(1), 2(1) and (2), 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ('the Act') as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order.

- 1. This Order shall come into operation on the 18th day of August 2023 and may be cited as the "City of Coventry (Upper Spon Street) (Prohibition of Driving and Revocation) Order 2023".
- 2. (i) In this Order
 - a) reference to an article followed by a number is a reference to the Article of this Order so numbered
 - b) "cause" includes permit and causing shall be construed accordingly
 - c) "enactment" means any enactment whether public, general or local and includes any order, bylaw, rule, regulation, scheme or instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of a subsequent enactment;
 - d) "vehicle" means:-

Coventry City Council

- i) a mechanically propelled vehicle intended or adapted for use on the road; and/or
- ii) a pedal cycle in actual use for the purposes of cycling
- iii) "vehicle", which shall for the avoidance of doubt include the whole or any part of a vehicle.
- e) the following expressions shall have the meanings assigned to them:-

"pedal cycle" has the same meaning ascribed to it as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;

"Road" shall have the same meaning ascribed to it by Section 142 of the Act

- (ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- 3. Save as provided in Article 4 of this Order, no person shall ride or drive or cause or permit to be driven or ridden any vehicle, in any direction, in the

- length of Upper Spon Street from its junction with Spon End/Butts to a point 4 metres east of its junction with Spon End/Butts.
- 4. Nothing in Article 3 of this Order shall apply to any vehicle listed in the First Schedule to this Order.
- 5. The Orders detailed in the Second Schedule to this order are hereby revoked to the extent detailed herein
- 6. The restrictions, prohibitions and requirements imposed by this Order shall be read and construed as not being in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.
- 7. Reference to any order law statute regulation or bylaw contained in this Order shall mean the order law statute regulation or bylaw as varied revoked updated or re-enacted.
