#### STATEMENT OF REASONS

# The City of Coventry (Citywide) (Permitted Parking Area and Special Parking Area) (Designation, Waiting Restrictions, Loading Restrictions, Loading Areas and Street Parking Places) Consolidation Order 2016 – Variation 12

Several road safety concerns have been raised by local residents in regard to problems caused by drivers parking at junctions, reducing visibility of and for exiting vehicles and in other locations, such as on bends. It is proposed to install waiting restrictions at these locations to prevent parking and improve road safety. In addition, in other areas issues have been raised regarding all day commuter parking; residents' parking schemes or controlled parking zones are proposed in these areas.

Some changes are proposed to reduce double yellow lines, where possible, to create additional on street parking.

The locations referred to above where changes are proposed are detailed in Appendix A.

As part of the low carbon agenda relating to transport the Council has installed many on street residential charge points across the city. There are advisory parking bays located alongside the charge points. It is proposed to install a restriction on some of these advisory bays to permit their use by Electric Vehicles only, whilst charging /topping up batteries, 8am – 10pm (7 days a week). These are detailed in Appendix B.

In addition, new restrictions and changes to existing waiting restrictions are proposed due to traffic management schemes as part of highway works relating to safety schemes or new developments. These proposals are to improve traffic management and road safety; these are detailed in Appendix C.

Reviews of existing restrictions have shown that there are some inconsistencies between Orders and restrictions indicated on the ground and these anomalies are being resolved by remaking the Orders. These locations are detailed in Appendix D.

It is also proposed to amend Schedule 4 to detail properties on:

Crabmill Lane (all properties), eligible to apply for Zone EW1 Parking Permits (for permit zone Paradise 1)

Queen Isabel's Avenue (all properties), eligible to apply for Zone C3 Parking Permits (for permit zone St Christians Road Area)

#### **REASONS**

When considering whether to make a traffic order the Council is under a duty pursuant to S.122 Road Traffic Regulation Act 1984 (as amended), to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway having regard to the matters specified in S.122 (2). It is considered that the proposals will generally assist to secure the safer movement of vehicular and pedestrian traffic. Furthermore, it is considered that the proposals will affect the matters specified in S.122 (2) as follows:

(a) the desirability of securing and maintaining reasonable access to premises;

The proposals will assist with the movement of traffic and will not adversely affect access to premises.

(c) the importance of facilitating the passage of public service vehicles and of securing the safety and convenience of persons using or desiring to use such vehicles; and

The proposals will assist with the movement of traffic.

The restrictions are to be installed in accordance with Section 1, Road Traffic Regulation Act 1984 as it provides that the Traffic Authority may make a Traffic Regulation Order, where it appears to the Authority making the order, that it is expedient to make it –

for avoiding danger to persons or other traffic using the road or any other road or preventing the likelihood of any such danger arising

for facilitating the passage on the road or any other road of any class of traffic (including pedestrians)

The Director of Transportation, Highways and Sustainability has delegated powers to request the advertisement of Traffic Regulation Orders.
