Thank you for your request for information relating to Coventry Home Finder.

You have requested the following information:

I'm requiring public information not personal information about Coventry Home Finder; this is under the freedom of information act. If you will not provide the information I shall take legal advice to get the Information/data.

1. First and last name of between 2021 to 2023 Coventry Home Finder staff

2. Their details: Job title, Office location, Email address

In response to Questions 1 and 2, it is Coventry City Council policy not to disclose the details of employees below 'Head of Service' level. The Council considers that this information meets the definition for personal data set out in Section 3(2) and 3(3) of the Data Protection Act 2018 (DPA) as:

(2) personal data means any information relating to an identified or identifiable living individual (subject to subsection (14)(c))"

(3) "Identifiable living individual" means a living individual who can be identified, directly or indirectly, in particular by reference to –

(a) an identifier such as a name, an identification number, location data or an online identifier, or (b) one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of the individual." Over the time period stated, the Head of Service with responsibility for the Coventry Homefinder service was (and still currently is):

3. Account closer by computer between 2021 to March 2023 Homefinder accounts.

In September 2021, a new Homefinder Policy and IT system was implemented. All applicants were required to re-register on the new system so that their applications and current circumstances could be assessed against the new Policy. This meant that in September 2021, all applications on the previous system were closed. On 13th September 2021, 13,268 applications were closed as part of this process. The period for re-registration started in June 2021, and applicants that re-registered and were accepted under the new policy were able to keep their previous registration date, provided they had re-registered by 31st December 2021.

Between 13th September 2021 (implementation of the new policy and IT system) and 31st March 2023, there were 5216 applications that were closed by the IT system, however these were closed as further information was required to enable the application to be assessed against the policy and this information was not provided within the required timescales, rather than live/active accounts being subsequently closed.

4. Male account holders number of applications held by a lead male during 2021 to March 2023

In September 2021, prior to the implementation of the new system/policy, 5380 applications had a male as the lead applicant

On 31st March 2023, 2781 applications had a male as the lead applicant.

5. Female account holders number of applications held by a lead male during 2021 to March 2023

In September 2021, prior to the implementation of the new system/policy, 7888 applications had a female as the lead applicant

On 31st March 2023, 3633 applications had a female as the lead applicant.

10. Length of account before closed by computer system – months or days

For accounts that were closed as part of the implementation of the new policy and IT system on 13th September 2023, the length of account ranged from a few days to 29 years. However, applicants that re-registered on the new system before 31st December 2021 were able to retain their original registration date.

For the applications that were closed between 13th September 2021 and 31st March 2023 (due to further information not being provided, before the application was made 'live'), the applicant had 28 days to provide additional documents before the application was closed.
