Thank you for your request for information relating to By-election costs.

You have requested the following information:

1. Under the terms of Freedom of Information Act please provide the costs incurred by Coventry City Council to run the by elections in Sherbourne in September 2022 and Binley & Willenhall in July 2022.

The costs should include items such as:

- a. Setup of temporary polling stations and hire of venues.
- b. Staff costs at polling stations and counting staff.
- c. Overtime costs for support staff
- d. Printing of ballot papers for polling stations Printing and delivery cost of postal votes.
- e. Transport and fuel costs.

Please see the attached documents for the Binley & Willenhall By-election on 14 July 2022 and the Sherbourne By-election on 22 September 2022.
