Infrastructure Funding Statement 2022/23

1. Introduction

- 1.1 This Infrastructure Funding Statement ('IFS') covers the period 1 April 2022 to 31 March 2023.
- 1.2 The <u>Community Infrastructure Levy Regulations 2010 (As amended)</u> requires all Local Planning Authorities to publish an annual IFS that provides information on planning obligations from section 106 agreements and Community Infrastructure Levy ('CIL') charges.
- 1.3 Coventry City Council has not adopted CIL as part of its development management process and the data in Section 3 of this report therefore only includes information regarding section 106 agreements.

2. Planning Obligations

- 2.1 Policy IM1 of the <u>Coventry City Council Local Plan 2017</u> establishes the Council's strategic approach for seeking developer contributions that mitigate the impact of development on existing infrastructure.
- 2.2 A section 106 agreement is a formal legal contract between a local planning authority and a landowner. It requires the landowner or developer to comply with certain obligations relating directly to a development. Such obligations must be fair and reasonable in scale and kind and may include on-site provisions such affordable housing, or financial contributions towards off-site infrastructure such as education and health.
