Election of parents to serve on the Governing Board of Hospital Education Service for a period of up to 5 years.

You may record one vote for up to **two** candidates of your choice. You may not vote twice for the same candidate or vote for more than **two** candidates. Each parent can submit one ballot paper, regardless of the number of pupils you have attending the school. As indicated on the ballot paper you should vote by marking an 'X' alongside the name(s) of the parent(s) you support.

Once you have marked the ballot paper you should seal it in the envelope provided. This should then be put in the ballot box, which can be found in Reception at Whitmore Park Annexe by **Monday 5**th **February 2024 at 3.30pm**. If it is not possible for you to vote in person, please return to the following address: FAO The Returning Officer, Whitmore Park Annexe, Between Houses 20-22 Rylston Avenue, Coventry, CV6 2HD.

The election will be decided by a simple majority of votes cast. In the event of a tie, lots will be drawn.

The counting of votes and declaration of result will take place on **Wednesday 7th February 2024**, and you will be informed of the result as soon as possible after that date.
