Notice is hereby given that Coventry City Council ("the Council"), under the Road Traffic Regulation Act 1984 (as amended), has made the following Traffic Regulation Order ("the Order"), which comes into operation on 1st March 2024:-

City of Coventry (Citywide) (Permitted Parking Area and Special Parking Area) (Designation, Waiting Restrictions, Loading Restrictions, Loading Areas and Street Parking Places) Consolidation Order 2016 - (Variation 12) Order 2024

The effect of the Order will be to:-

i) extend two existing residents' parking schemes:

- Zone C3 Queen Isabel's Avenue (extension of existing scheme); and
- Zone EW1- Crabmill Lane (extension of existing scheme)

ii) add to, vary or amend the waiting restrictions on certain lengths of the following roads: -

Stanier Avenue Area (Stanier Ave, Worsdell Close, Collett Walk, Hawksworth Drive)	Proposed change to existing restriction from 'No Waiting, Monday to Friday, 9am - 11am & 2pm - 4pm' to 'No Waiting, Monday to Friday, 8am - 9.30am & 2.45pm - 4.30pm'. To retain existing (No Waiting, Monday to Friday, 9am - 11am & 2pm - 4pm')
Upper Spon Street	Proposed to simplify existing limited waiting restrictions on each side of the road (near Barras Lane junction).

When originally advertised the title of the Order (as proposed) was City of Coventry (Citywide) (Permitted Parking Area and Special Parking Area) (Designation, Waiting Restrictions, Loading Restrictions, Loading Areas and Street Parking Places) Consolidation Order 2016 - (Variation 12) Order 2023. The title has since been changed to that set out above.
