## DECLARATION

Please read this declaration carefully and then sign and date it.


I give notice that I have set out above, under the appropriate headings, my pecuniary interests which I am required to register under the Localism Act 2012 and the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and the Member Code of Conduct adopted by Allesley Parish Council. I have indicated appropriately where I have no such interests under any such headings.

I understand that, under Section 31 of the Localism Act 2012, if I am aware that I have a disclosable pecuniary interest in any matter to be considered or being considered at a meeting of Parish Council, which is not entered in the register or the subject of a pending notification, I must notify the Acting Monitoring Officer of that interest within 28 days of the date of the meeting.

I further understand that, under Section 34 of the Localism Act 2012, I may commit a criminal offence and, on conviction, be liable to an unlimited fine and to disqualification as a member for up to 5 years if:

- (a) Without reasonable excuse, I fail to comply with an obligation to:
  - (i) notify the Monitoring Officer of any disclosable pecuniary interests which I have within 28 days of becoming a member or co-opted member of the Parish Council; or
  - (ii) disclose a disclosable pecuniary interest to a meeting of the Parish Council where to my knowledge I have such an interest in a matter being considered at the meeting and where the interest has not been entered onto the register of interests; or
  - (iii) notify the Monitoring Officer of a disclosable pecuniary interest within 28 days of the date of a disclosure at a meeting as set out in (ii) above unless the interest is the subject of a pending notification; or
- (b) Without reasonable excuse:
  - (i) I participate in any discussion or further discussion or vote or further at a meeting in connection with a matter in which I have a disclosable pecuniary interest or
  - (ii) I knowingly provide information which is false or misleading or am reckless as to whether the information is true or not misleading in connection with my obligations under paragraphs (a)(i), (a)(ii) or (a)(iii)
