# What is a Forced Marriage?

A forced marriage is where one or both people do not consent to the marriage and pressure, or abuse is used. Those assessed to lack capacity, cannot consent. An Arranged Marriage is where both participants give their full consent and enter the marriage willingly. This includes people of all ages, genders, ethnicities and religion.

Forced marriage is different to arranged marriage where families are involved in selecting a partner, but it is up to the individuals to decide whether or not to enter the marriage. Some structures that are used in an arranged marriage may also be used in a forced marriage and this can often become confusing in distinguishing between them. The key distinction is that a forced marriage involves a lack of consent by one or both parties and where coercion or pressure may be a factor.

## **Facts and Motivation for Forced Marriage**

- Controlling unwanted behaviours.
- ► Stopping unsuitable relationship from forming
- Listening and being pressured by peer groups, extended families, communities.
- Protecting family honour (izzat)
- Attempting to strengthen family links, alliances and bonds,
   UK & Abroad
- Assisting claims for country residence.
- ► Financial gain
- ► Ensuring land, property and wealth remains within the family.
- ▶ Protecting tradition, religion and culture, values and morals
- ► History of BME communities' importance on marriage and preparation through life and childhood to obtain honour.

## What Can I do?

If you know someone that is being forced into marriage either in the UK or abroad, you can contact the Forced Marriage Unit (FMU). The FMU will provide support both before and after you report the issue to the police or if you decide not to.

If the person is in immediate danger, call the police on 999.

Where information suggests that an adult is at risk of being forced to marry, you should also contact Adult Social Care Direct on 024 7683 3003.

#### One Chance Rule

Do: Do not:

Take them seriously, see them immediately and alone Approach family or community

Establish their wishes and reassure them Send them away

Establish means of safe contact Share information without consent

Contact the FMU for advice Attempt to mediate

#### The Law

The Anti-social Behaviour, Crime and Policing Act 2014 made it a <u>criminal offence</u> in England, Wales and Scotland to force someone to marry. It can result in up to 7 years imprisonment. It is a form of domestic abuse and a serious abuse of human rights.

FMPO's are civil law measures and can be applied for in the family court. Failure to comply with the requirements or terms set out in a FMPO granted by the Family Court, <u>is a criminal offence and can result in a sentence of up to 5 years in prison.</u>

Forcing someone to marry can result in a sentence of up to 7 years in prison.

In 2017 the government introduced lifelong anonymity for victims of forced marriage to encourage more victims of this hidden crime to come forward.
