All banned breed dogs that are seized by Coventry Council are kept in our own kennels, therefore, no kennelling fees are incurred. There is a cost of £180.00 per dog for euthanasia.

- Any dogs that are euthanised are either done via Birmingham Dogs home or if done by us (note this will be performed by a vet which involves a general cremation)

Key performance indicators:

- Accept stray dogs Monday to Friday 8am 4pm
- Keep stray dogs for 7 days
- Walk, feed, clean and look after the wellbeing of dogs 7 days a week including weekends and bank holidays
- Have a designated vet
- Fully trained staff on site

We do not take surrendered dogs from the public or any other organisation/vets or Police. We only deal with stray dogs or social services cases.

Individual burial
Communal burial
Carcasses donated and to whom
Carcasses sold and to whom and payments made

Any dogs that are euthanised is done by a vet and disposed of by them.

Since 10 June 2024 it has been a legal requirement to microchip cats. We request the following information:

No, we do not collect stray cats.
