Thank you for your request for information relating to Ukraine monies spend to date.

You have requested the following information:

We are researching the amount of money actually spent on Ukrainian refugees to date, over the nearly 3 years that Ukrainians have been arriving to us. Please provide the following data to us under the Freedom of Information Act. As you are obliged to report much of this to MHCLG, it should be easily available.

We would like the information broken down into 3 categories - A, B, C - as described below. Answers can be provided after the colons, in an email response.

A. Homes for Ukraine Tariffs received

Please provide the total H4U tariff you received to date (not including the Homelessness Prevention, host 'thank you' payments or Education grants, which are all additional): We will crosscheck against Homes for Ukraine funding - GOV.UK (www.gov.uk) where these numbers are published. This is on the basis of £10500 per H4U arrival up to 31 Dec 2022, and £5900 per adult H4U arrival after this date (children remained at £10500 throughout).]

The information you requested falls under the exemption(s) in Section 21 of the Freedom of Information Act 2000, which relates to 'information reasonably accessible to the applicant by other means.'

We hold the information which you have asked for, but we have estimated that the cost of meeting your request would exceed the cost limit of £450 specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees Regulations 2004). This represents the estimated cost of one person spending 18 hours or more, in determining whether the information is held, locating, retrieving and extracting it.

We are unable to provide this information as it is not recorded in a reportable format. It would require an officer to check the file notes for each award of funding made, to cross reference whether they were Ukrainian Refugees. This will exceed 18 hours work and therefore this part of your request has been refused under section 12(2) of the Act.
