A reminder: Dates for 2024-2025

On Tuesday 1 October, STA updated their primary assessments future dates with the:

- detailed timetable for the KS2 tests in May 2025
- new downloadable KS2 calendar with all important dates for the academic year 2024 to 2025
- expected dates for tests and assessments in primary school throughout the academic year 2026 to 2027

They have also since added the KS1 calendar.

STA Assessment Timetable Academic year 2024 to 2025

Reception baseline assessment

Schools must complete the reception baseline assessment for each child in the first 6 weeks after they enter reception.

Early years foundation stage profile assessment

Schools must complete the early years foundation stage profile assessment between April and June of the academic year in which children turn 5, which is usually the reception year.

Optional key stage 1 tests

It is recommended by STA that the optional key stage 1 tests are administered during May 2025.

Key stage 2 tests

The statutory key stage 2 tests are timetabled from Monday 12 May to Thursday 15 May 2025

Multiplication tables check

Schools must administer the multiplication tables check within the 2-week period from Monday 2 June 2025.

Phonics screening check

Schools must administer the phonics screening check within the 1-week period from Monday 9 June 2025.

STA Updates: independence in Writing KS2

STA have again added to their guidance on independent writing at then end of KS2, to include **the use of Al**:

Writing is not independent if it has been:

- modelled or heavily scaffolded as part of external moderation, local authority moderators can discuss where they find modelled or scaffolded writing, and they may ask for further examples of a pupil's work to support the standard and judgement
- copied or paraphrased, including producing work that demonstrates an over-reliance on a model text
- edited or re-written because of direct intervention by a teacher or other adult – for example, when the pupil has been directed to change specific words for greater impact, where incorrect or omitted punctuation has been indicated, or when incorrectly spelt words have been identified by an adult for the pupil to correct
- produced with the support of electronic aids that automatically provide correct spelling, synonyms, punctuation or predictive text if the electronic aid is turned off, such as spell check and grammar in a word programme, this would be considered independent
- produced, either in full or in part, using large language models or other forms of artificial intelligence use of these could result in the school being investigated for maladministration
- supported by detailed success criteria that specifically direct pupils what to include, or where to include it, in their writing for example, directing them to include specific vocabulary, grammatical features or punctuation.

For teacher assessment to be accurate, robust and reliable, it is important that all staff participate in standardisation activities and moderate their judgements. Therefore the Local Authority offers the opportunity for Y6 staff to attend a central standardisation and moderation session - an invaluable session for Y6 teachers led by the KS2 Moderation Manager. STA updates and good practice with regard external moderation will be shared, as well as the use of standardisation materials. Teachers are asked to bring collections of pupils' work for discussion alongside Coventry moderators. This is ideal preparation for making final TA judgements.
