Thank you for your request for information relating to Private school placements.

You have requested the following information:

- 1. How many pupils with special educational needs and disabilities (SEND) are being educated in independent schools paid for by council?
- a) Please break down the numbers by financial year for the following years 2023/4, 2023/22; 2021/22
- b) Please break down by private schools inside and outside borough
- c) Please break down the cost of these independent placements by financial year for the following years 2023/4; 2023/22; 2021/22

For example, in the financial year 2023/4, the council funded 145 pupils with SEND to attend independent special schools. 50 pupils attended private schools outside of the borough/ in a different local authority's area. The total cost of these private school placements was £54,000

In response to your request, please see the breakdown below:

## 2023/2024

Coventry City Council placed 157 students in independent schools. 152 were outside of Coventry's boundaries.

The total cost of these placements was £7,123,989.06

# 2022/2023

Coventry City Council placed 153 students in independent schools. 145 were outside of Coventry's boundaries. The total cost of these placements was £5,725,032.37

## 2021/2022

Coventry City Council placed 124 students in independent schools. 117 were outside of Coventry's boundaries. The total cost of these placements was £5,360,602.62
