Freedom of Information Act 2000 (FOIA) Request ID: FOI680743289

Thank you for your request for information relating to S19 and education provision.

You have requested the following information:

### 1. How many days on average are children left without an Educational Provision?

We hold the information which you have asked for, but we have estimated that the cost of meeting your request would exceed the cost limit of £450 specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees Regulations 2004). This represents the estimated cost of one person spending 18 hours or more, in determining whether the information is held, locating, retrieving and extracting it.

The requested information is not held in a reportable format. In order to answer this part of your request, an officer will need to manually check individual pupil records and due to the volume of records to check, we estimate that this will exceed 18 hours. This part of your request has been refused under section 12(2) of the Act.

- 2. How many students do you have under a S19 Currently? 39 as at 24 January 2025.
- 3. How many of those can not attend a school or collage or academy at all? Zero, as at 24 January 2025.
- **4.** How many are still on roll with an Education provider whilst having an AP? 39 as at 24 January 2025.

# 5. How many AP's that you are currently using whilst the student is on roll elsewhere, are DfE/OFSTED accredited?

Three.

Please note that students may be on the role of the AP accredited provision.

Out of the students not attending a school college or academy at all, but are still on roll:

### 6. How many are provided a face to face AP only?

Out of the 39 children above, 37 are receiving face to face provision.

# 7. How many are having a mixed AP part face to face & part online provision? Two.

## 8. What online system are you using?

The Complete Education Solution (TCES) which is an online school.

# **9.** How many are being provided only an online education as an AP? Zero, as at 24 January 2025.
