Thank you for your request for information relating to Bus gates.

You have requested the following information:

1. How much is the full, undiscounted penalty for a bus gate breach in your authority (i.e. Driving an unpermitted vehicle through a bus gate)?

£70.

2. How many bus gates and bus lanes do you operate in your authority?

There are currently six enforceable bus gates or bus lanes in Coventry.

- 2a) Please break these down into separate counts of bus lanes and bus gates.
- 2b) For the year 2024, please provide the number of bus gate breaches recorded in your authority.

For clarity, I am requesting only bus gate breaches rather than bus lane breaches. If this is not possible, please provide the total number of bus lane and gate breaches recorded in the year 2024.

In response to Questions 2a and 2b, we refer you to the attached table.

Please note the attached table shows a list of bus gates and bus lanes which were in operation as at 31/12/2024, along with the number of penalty notices issued at each location in 2024.

The supply of information in response to a FOI request does not confer an automatic right to re-
