Thank you for your request for information relating to Fines for unauthorised term-time holidays (Metropolitan).

You have requested the following information:

1. Please provide the total number of fines issued for unauthorised school absences due to term-time holidays in each of the last 3 calendar years (2022, 2023, 2024). Please break this down by month. If you don't have a monthly breakdown, please provide a yearly total.

In response to Question 1, we refer you to the attached table.

2. Please provide the total revenue generated from these fines in each of the last 3 calendar years (2022, 2023, 2024).

In response to Question 2, we confirm we do not hold this information and are informing you as per Section 1(1) of the Act. We do not keep a separate account of income generated for unauthorised school absences due to term-time holidays.
