Thank you for your request for information relating to Section 47 enquiries or investigations, puberty blocker access for children.

You have requested the following information:

1. Please confirm whether your local authority has issued/commenced a Section 47 enquiry or investigation as per the Children's Act of 1989 concerning a child and/or their parents/guardian in relation to overseas access to puberty blockers since May 2024.

2. If yes, please list the total number of Section 47 investigations or enquiries concerning overseas access to puberty blockers, since May 2024.

For Questions 1 to 6, we hold the information which you have asked for, but we have estimated that the cost of meeting your request would exceed the cost limit of £450 specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees Regulations 2004). This represents the estimated cost of one person spending 18 hours or more, in determining whether the information is held, locating, retrieving and extracting it.

The information is not held in a reportable format hence it would require an officer to manually review each record to determine what information is held and collate the relevant data. It has been estimated that this would exceed the 18-hour limit under the Act to complete. Your request has been refused under section 12(2) of the Act.
