## City of Coventry (Lamb Street) (One Way) Order 2025

Coventry City Council, in exercise of their powers under Sections 1(1), 2(1) (2) (3), 4 (2) and 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. This Order shall come into operation on the 17<sup>th</sup> day of February 2025 and may be cited as the "City of Coventry (Lamb Street) (One Way) Order 2024"
- 2. i) In this order:
  - (a) A reference to an article followed by a number is a reference to the Article of this order so numbered
  - (b) "cause" includes permit and causing shall be construed accordingly
  - (c) "enactment" means any enactment whether public, general or local and includes any order, bylaw, rule, regulation, scheme or instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of a subsequent enactment;
  - (d) "vehicle" means
    - (i) a mechanically and/or electrically propelled vehicle intended or adapted for use on the road,
    - (ii) a pedal cycle in actual use for the purposes of cycling

which for the avoidance of doubt shall include the whole or any part of a vehicle.

- (e) The following expressions shall have the meanings assigned to them:-
  - "the 2016 Regulations" means the Traffic Signs Regulations and General Directions 2016 and includes any enactment or re-enactment or amendment thereto;
  - "pedal cycle" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;
- ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament
- Save as provided in Article 4 of this Order, no person shall ride or drive or cause or permit any vehicle to proceed on Lamb Street, other than in an easterly direction (for the avoidance of doubt from west to east)
- 4. Nothing in Article 3 of this Order shall apply to any vehicle listed in the Schedule to this Order.



- 5. Any order which imposes a restriction on the direction of travel along Lamb Street shall be revoked with effect from the date of this order.
- 6. The restrictions, prohibitions and requirements imposed by this Order shall be read and construed as not being in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment.

## **SCHEDULE**

## Nothing in Article 3 of this order shall apply to a:-

- (a) pedal cycle
- (b) any vehicle being used for police, fire or ambulance service purposes in circumstances of emergency
- (c) vehicle being used for the removal of any obstruction to traffic
- (d) any vehicle being used in accordance with any indication given by a traffic sign which has been placed pursuant to section 66 or 67 of the Act
