**Freedom of Information Act 2000 (FOIA)**

Thank you for your request for information relating to Keresley Link Road.

You have requested the following information:

**1. I will be obliged to know the present status concerning The Keresley Link Road.**

The current status is that the Link Road is still a live project and is still to be delivered, subject to planning approval for the phase from Bennetts Road to Winding House Lane and funding moving forward.

**2. When is ground estimated to be broken on the east side of Bennett's Road for its construction.**

There is no current timeline for this section of the Link Road.

**3. Is the Council still financing the stretch running from Watery Lane to Winding House Lane ??**

The Council would not be funding this section, however we would draw down on contributions from local developers, along with any additional top-up funding we would be applying to external funders for support.

**4. Is the remainder of the road being paid for by the developers of the urban extension proportionally to the size of areas/no of houses it will run through ??**

Where the Link Road runs through or adjacent to a development site, the developer has a right to construct this section, or agree on a fee to pay the Council to procure a contractor and deliver the

works.

## **5. Any other relevant information will be appreciated.**

The section from the end of the Taylor Wimpey site, across Hall Brook and up to the boundary of Bellway homes/Vistry is currently being developed, and we aim to begin the work this year and complete the work next year.
