In turn, Policy DS2 Part 1 would not result in the entirety of the employment land requirements being met and is therefore unsound.							

Part 7 of Policy DS2 relates to Duty to Cooperate partners helping to meet the identified employment land shortfall. This is not reinforced by a Memorandum of understanding, or Statement of Common ground that is publicly available, and therefore this policy does not commit to ensuring that the identified employment land shortfall will be met.

Policy DS2 can therefore not be considered sound in conjunction with Policy DS1.
