The University is supportive of Chapter 12: Accessibility and is pleased to acknowledge that the majority of consultation comments raised by the University during the Reg 18 consultation have been considered and incorporated into the Reg 19 version. The University particularly supports the strengthening of the hierarchical prioritisation of transport infrastructure, leading with active and sustainable transport as the primary focus for investment and key driver for travel behaviour change.

**Policy AC1: Accessible Transport Network**

The University acknowledges and supports the inclusion of a stronger emphasis on the need to prioritise active and sustainable modes of transport in terms of integration with the surrounding networks. The inclusion of placemaking and local connectivity to reduce dependence on private vehicle trips is an important addition as well as integration between the built form and delivery of new and improved local transport networks prioritising walking and cycling and sustainable modes of travel in both a local context and within strategic growth corridor locations.

**Policy AC2: Road Network**

The University supports the inclusion within Policy AC2 to require developments to support the provision and integration of intelligent mobility infrastructure, such as EV charging. This ensures a more significant and continued provision of EV infrastructure across the UK is achieved to meet the targets set by the Government. The University's Masterplan SPD also seeks to significantly increase EV provision for car, bikes, service vehicles and scooters on campus as part of a forward-thinking mobility strategy.

**Policy AC3: Demand Management**

The University supports the additional reference at Paragraph 3, relating to the wider consideration of active and sustainable modes forming part of the delivery of new parking provision. There is also support of the inclusion to encourage and incentivise sustainable travel through the provision of Mobility Credits.

However, the University still advocates that credits will only be successful if the individuals continue to commit to the travel behaviour change once the credits expire. Therefore, developments must invest in high quality active design, placemaking and integration with the surrounding transport network to ensure sustainable and active travel is a real, long-term alternative as set in Policy AC1.
